# PESCATORI DI PORTE 2° Edition / Year 2020

The TAMBÚCA Cultural Association renews *Pescatori di Porte* project and launches the second edition for the year 2020: an international painting competition for the decoration of the fishermen's doors behind the new Viareggio Fish Market.

A permanent open-air exhibition, a gift to the sea and its caretakers.

#### THEME OF THE COMPETITION

"The sky over fishermen"

#### Art. 1 - AIM OF THE PROJECT

The TAMBÚCA Cultural Association announces the second edition of the international competition for artists, with the aim of redeveloping an area of the port of Viareggio adjacent to the new fish market, to promote and enhance contemporary art. The area in question is that of the sheet metal warehouses of the Cittadella dei Pescatori which land at the port, specifically the overhead doors of the corrugated sheet warehouses.

# For the year 2020 the decorations of 10 doors will be created.

The competition includes the selection of **10 finalists** (including **3 winners**), who will have the opportunity to realize their artwork on the doors of the fishermen's warehouses, and **10 special mentions** that will take part, together with the finalists, in the collective exhibition in a historic villa in Viareggio.

#### **Art. 2 - ADMISSION CRITERIA**

The competition is open to all artists, of all nationalities, starting from 16 years of age (the participation of underage artists is subject to the authorization of those who exercise their fatherland).

In particular, the competition is dedicated to:

- Artistic high schools and national and international Fine Arts Academies.
- Independent artists of any nationality and level.

Fundamental selection criteria will be quality, research, originality and contemporaneity, creativity of the work and consistency with the proposed theme. There will be no limitations of technique or style, as long as it is a painting as faithful as possible to the result of the realization on the sheet metal door. By pictorial work we mean any use or manual intervention in oil, tempera, acrylic, industrial paint, ink, engraving, graphite, watercolor, vinyl, on any type of substrate, even pre-printed, provided that it is kept in mind that the work must be reproduced faithfully with an enamel brush on a corrugated metal support (on the website the photographic material of the supports to be decorated). **The size of each work must be 50 x 60 cm in horizontal orientation**; if the original work is chosen from among the finalist works for participation in the group exhibition, it must be equipped with a frame and hangers, under **penalty of exclusion from the competition**.

# **Art. 3 - TERMS AND CONDITIONS**

Artists can register and submit the work in competition **no later than April 19, 2020**, using the following method:

- **Online** on the website www.tambucaversilia.it in the "Pescatori di Porte" section, following the instructions
- **By email** by sending the following material by email to the address pescatoridiporte@tambucaversilia.com:
  - Registration form completed and signed (attached to the announcement)
  - Receipt of payment of the registration fee
  - Image of the artwork in competition which must be presented in high definition digital format (recommended resolution 300 dpi with a size not exceeding 3 MB)
  - Brief description of the proposed work.
  - Short biography

NB: Applications that do not comply with the information requested will be automatically excluded from the competition.

#### Art. 4 - ENTRY FEE

The registration fee includes the partial coverage of the organization costs. The participation fee is set at:

# **SCHOOLS / HIGH SCHOOLS / ACADEMIES** from all over Italy

<u>Free</u> - for classes or school groups up to a maximum of 3 processed at school. Only for projects proposed directly by the school / high school / academy, for which a leader will be appointed.

<u>Payment of the registration fee must be made in Euros, without bank fees or commissions charged to the Organization.</u> The registration fee is not refundable.

#### **Art. 5 – PUBLICATION OF THE ARTWORKS**

Only the 10 finalist works (including the winners) will be published on the site plus the 10 special mentions chosen by the jury.

For the finalists, a sheet will be created on the website containing the work in competition, a short biography and the work in progress of creating the decoration for each artist.

After a first selection of the applications, the finalists will be asked to send the artwork for the realization of the collective exhibition.

The finalist works must be presented complete with opaque white frame size 50 x 60 cm and complete with hangers, with or without plexiglass, depending on the technique used. For example, the plexiglass panel is not necessary for oil and acrylic works with final paint.

The transport costs for sending and collecting the selected works are borne by the participants.

The jury's decisions are final and unappealable.

#### Art. 7 - PRIZES

For the second edition of the Pescatori di Porte competition 10 finalists will be selected, who will have the opportunity to create the decoration on the doors, and 10 special mentions, who will participate in the group exhibition of the prize.

During the door decoration phase, the jury will select the **3 winning artists, who will be entitled to cash prizes**. The selection of the winners will be based on professionalism, technique and speed of execution, loyalty to the sketch proposed during the application phase and autonomy in the management of the work. Account will be taken of age and previous experience in the field.

#### **SPECIAL MENTION PRIZES**

- Free participation in the group exhibition in locations to be defined; the award ceremony will take place on Friday 12 June, where certificates of participation in the competition will be awarded.
- Inclusion in the paper catalog and publication of the artworks on the website.
- N. 1 free copy of the catalog.

#### **FINALISTS PRIZE**

- Realization of the pictorial decoration with materials provided by the sponsor CROMOLOGY, which must be carried out in a maximum of 6 consecutive days in the weeks 29 May / 3 June, or 8/13 June 2020. The Tambúca cultural association will provide free accommodation for the finalists for a maximum of 6 nights in a partner facility or at your location.

# **Art. 11 - CATALOGUE**

The catalog will contain photos of the works of the 10 finalists with a short biography of the artists, plus 10 special mentions. Copies of the catalog can be purchased during the exhibition or directly online on the association's website. A copy will be delivered free of charge to each of the finalist and mentioned artists.
